- Lashing & Choking and Fumination shall be charged at actuals
- Prior to Movement of Export Cargo / Container or Delivery of Import Cargo / Container, Customer must clear all dues.
- All DD / Cheque to be drawn in favour of "Seabird Marine Services Pvt Ltd", Hazira. For RTGS, please contact cash counter.
- Shipping Line/CHA will be required to pay custom overtime , if any required for work done at CFS
- Any spill cleanup charges accruing on account of handling of HAZ cargo, disposal of the HAZ waste to a govt. approved waste handling facility including transportation to such facility shall be borne by the customer (Shipper / Importer).
- Taxes, levies, cess etc including service tax, shall be charged separately, as applicable.
- Penalty of INR 5000/- per instrument will be levied for dishonor of cheque, for whatsoever reason.
- CFS Shall not be responsible for any loss/damage/shortage/moisture loss etc after the sealed container left the premises.
- Rates are subject to change without prior notice.
- It is presumed that all consignments (Import/ Export) being received at CFS are adequately insured against all possible risk during transportation and storage and the company (Seabird Marine Services Pvt Ltd) assumes No liability in this respect
- Ground Rent / Storage Charges for Hazardous and ODC container/ cargo will be charged @ 2 times of the normal rate.
- If ODC container/ cargo is to be moved on low bed trailers, Extra movement charges will be @ Rs 20000/- per container will be collected.
- H & T charges for & 45' containers will be 2.5 times respectively, on per TEUs rates, unless specified otherwise.
- H & T charges for F/R, ODC & Haz Containers shall attract premium of 25% over & above rates precribed herein.
- Rates for services not mentioned herein above shall be quoted on case to case basis.
- Any other operating cost will be recovered by way of SSR on case to case basis
