TERMS AND CONDITIONS

- **1.** All charges are per TEU basis unless specified otherwise.
- **2.** Ground rent charges for Reefer cargo in containers whether Import or Export, 200% of the normal rate. (For F/R& ODC, 3 times of the normal rate).
- 3. H&T Charges for & 45' containers will be 2.5 times respectively, on per TEU rates, unless specified otherwise.
- **4.** Special handling charges of Rs.1000/- per TEU/per shipping bill or bill of entry for a maximum of 3 vehicles or Rs.1000/- per vehicle will be charged extra if 10-ton fork-lift is used for loading/unloading cargo. Shifting charges SSR@ Rs.1000/- per teu would be applicable only on a case to case basis to offset operating cost. Container Segregation& stacking charges of Rs.1500/- per teu will be applicable on case to case basis. Any other operating cost will be recovered by way of SSR on case to case basis.
- 5. The chocking& lashing rates are applicable for standard design. Any additional materials will be charged extra.
- 6. Taxes including service tax, wherever applicable will be charged extra.
- **7.** For safety reasons if ODC container/ cargo is to be moved on Low Bed Trailers, Extra movement charges will be @ Rs 20000/- per container will be collected. Formal normal ODCs, vehicle detention Charges for On-hook delivery will be Rs 6000/- for TEU and Rs 10000/- for feu.
- 8. Dock Destuff charges @2500/- per teu will be collected Additional.
- 9. Ground rent/ storage charges for Hazardous container/ cargo will be 3 times of the normal rate.
- **10.** The CFS does not take any responsibility for risk related to the cargo except to the extent required under the Customs Act, and it is assumed that all Cargo owners have covered Transits and Storage of their cargo while in our custody or at our premises with a valid and subsisting insurance for all risks, for an amount equivalent to the full value of the cargo including GST, as may be applicable.
- **11.** Facility Maintenance Charges for LCL cargo is Rs.100peritem.
- 12. Handling and Transportation charges LCL for Hazardous Cargo: 20FT -20350/-,40FT -34150,45FT-44405.
- 13. Delivery of container / cargo is subject to completion of custom & other legal formalities.
- **14.** In case of congestion at port terminal, vehicle detention charges shall be levied appropriately.
- **15.** Additional Handling & Other Charges at Port Rs. 350.00 Per teu. 16. Haz and Open Yard Cargo storage charges will be two times of the normal cargo.
- 16. For DPD Containers additional administrative charges accrued at port will be charged extra.
