2. Prior to Movement of Export Cargo / Container or Delivery of Import Cargo / Container, Customer must clear all dues.
3. All DD / Cheque to be drawn in favour of "SEABIRD MARINE SERVICES PVT LTD", Hazira. For RTGS, please contact cash counter.
4. Shipping Line/CHA will be required to pay custom overtime, if any required for work done at CFS Any spill cleanup charges accruing on account of handling of HAZ cargo, a customer (Shipper / Importer). govt. approved waste handling facility including transportation to such facility shall be borne by the disposal of the HAZ waste to.
5. Taxes, levies, cess etc including GST, shall be charged separately, as applicable.
6. Penalty of INR 5000/- per instrument will be levied for dishonor of cheque, for whatsoever reason.
7. CFS Shall not be responsible for any loss/damage/shortage/moisture loss etc after the sealed container left the premises.
8. For Import Destuff/Export Carting sweeping/cleaning charges for spilled cargo applicable INR 500 / per TEU.
9. It is presumed that all consignments (Import/ Export) being received at CFS are adequately insured against all possible risk during transportation and storage and the company (Seabird Marine Services Pvt Ltd) assumes No liability in this respect.
10. Ground Rent / Storage Charges for Hazardous,ODC and Reefer container/ cargo will be charged @ 2 times of the normal rate.
