2. Ground rent charges for Reefer cargo in containers whether Import or Export, 200% of the normal rate. (For F/R& ODC, 3 times of the normal rate).

3. H&T Charges for & 45' containers will be 2.5 times respectively, on per TEU rates, unless specified otherwise.

4. Special handling charges of Rs.1000/- per TEU/per shipping bill or bill of entry for a maximum of 3 vehicles or Rs.1000/- per vehicle will be charged extra if 10-ton fork-lift is used for loading/unloading cargo. Shifting charges SSR@ Rs.1000/- per teu would be applicable only on a case to case basis to offset operating cost. Container Segregation& stacking charges of Rs.1500/- per teu will be applicable on case to case basis. Any other operating cost will be recovered by way of SSR on case to case basis.
